## Privacy Policy

Future Artists of Los Angeles (“FALA,” “we,” “our,” or “us”) is a nonprofit arts organization that operates the **Los Angeles Community of Acting & Entertainment Theatre and School** (“LACAE”). This Privacy Policy explains how we collect, use, and protect your information when you visit our website <https://la-cae.org> (the “Site”), register for events or programs, make donations, or otherwise interact with us online.

## 1. Information We Collect

### Personal Information

We may collect personal information you voluntarily provide, including your name, email address, phone number, and mailing address, when you sign up for updates, register for programs or events, complete forms, or make donations.

### Payment Information

Payments and donations are processed securely through trusted third-party platforms such as Wix Payments, Stripe, PayPal, or GiveButter. We do not store full payment card details on our servers.

### Automatically Collected Information

We may collect certain information automatically, such as IP address, browser type, device information, and pages visited, through analytics and tracking tools including Google Analytics, Wix Analytics, and Meta Pixel.

## 2. How We Use Your Information

We use the information we collect to:

- Communicate about programs, workshops, performances, and events
- Process registrations, payments, and donations
- Provide operational and administrative updates
- Improve our programs, services, and website experience
- Send marketing or fundraising communications **if you opt in**
- Send **informational SMS communications if you explicitly opt in**

## 3. Information Sharing

We never sell or rent your personal information for any reason.

**SMS opt-in data, consent records, and phone numbers are never shared with third parties for marketing purposes.** SMS-related information is used solely to deliver authorized informational messages on behalf of Future Artists of Los Angeles and the Los Angeles Community of Acting & Entertainment.

## 4. Cookies & Tracking Technologies

We use cookies and similar technologies to analyze website traffic, understand user behavior, and improve our online experience. You may disable cookies through your browser settings, though some site features may not function properly.

## 5. Data Retention

We retain personal information only for as long as necessary to fulfill the purposes outlined in this Policy or as required by law.

We do not knowingly collect personal information from children under the age of 13. If we become aware that such information has been collected, we will take appropriate steps to delete it.

If you provide your phone number through our website and **check an explicit SMS consent box**, you consent to receive **informational text messages** from **Future Artists of Los Angeles, operating the Los Angeles Community of Acting & Entertainment Theatre and School**,

related to classes, workshops, schedule updates, events, and other important program-related announcements.

- Message and data rates may apply
- SMS consent is **not a condition of purchase**
- You may opt out at any time by replying **STOP** (you will receive a confirmation message)

SMS consent is collected separately from email consent and is documented via an unchecked-by-default website form checkbox.

We do not share, sell, or disclose SMS opt-in data or phone numbers to third parties for any purpose.
