Privacy Policy

Future Artists of Los Angeles (“FALA,” “we,” “our,” or “us”) operates the website <https://la-cae.org> (the “Site”). This Privacy Policy explains how we collect, use, and protect your information when you visit our Site, register for events, donate, or interact with us online.

1. Information We Collect

- **Personal Information:** Name, email, phone number, and mailing address when you sign up for updates, events, or make donations.
- **Payment Information:** Processed securely through trusted third-party platforms such as Wix Payments, Stripe, PayPal, or GiveButter. We do **not** store full payment details.
- **Automatically Collected Data:** Such as IP address, browser type, and pages visited, collected through analytics tools (Google Analytics, Wix Analytics, Meta Pixel).

2. How We Use Information

We use your information to:

- Communicate about programs, workshops, and events.
- Process payments and donations.
- Improve our offerings and website experience.
- Send marketing or fundraising updates (if you opt in).
- Send SMS communications (if you opt in via website form).
- Comply with legal obligations.

3. Information Sharing

SMS opt-in data, consent records, and phone numbers will never be shared with any third party, including service providers, for any purpose other than delivering authorized SMS messages.

4. Cookies & Tracking

We use cookies and similar technologies to personalize content and analyze traffic. You can disable cookies in your browser; some features may not function properly.

5. Data Retention

We retain your data only as long as necessary to fulfill its purpose or as required by law.

7. Security

We maintain reasonable administrative, technical, and physical security measures to protect your data, though no system is entirely secure.

8. Third-Party Links

We are not responsible for the privacy practices of external sites.

9. Children's Privacy

We do not knowingly collect data from anyone under 13.

10. SMS Communications & Opt-In

If you provide your phone number through our website and check the SMS opt-in box, you consent to receive text messages from Future Artists of Los Angeles regarding workshops, classes, events, and related updates.

- Message & data rates may apply.
- **Message frequency:** Recurring messages may be sent periodically; message frequency may vary and will not exceed four messages per month.
- You may opt out at any time by replying **STOP** (you will receive a confirmation message).

- Your consent is documented via website form checkbox, which is unchecked by default.
- We do not share, sell, or disclose SMS opt-in data or phone numbers to third parties for any purpose.
